### Facilitator Training for the M<sup>POWRD</sup> Leadership Program

This two-day program offers a comprehensive approach for individuals planning to offer M<sup>POWRD</sup> within their facilities. Redefining addiction, unconditional support, new strategies in teen empowerment, confidentiality factors, creating balance and trust are several of the key components which will be emphasized at the training. Breakout sessions include simulating teen meetings and developing empowerment with life strategies. Lesson plans will be provided and reviewed for consistency in approach and outreach. All materials for implementing this program will be provided.

Facilitator certificates will be offered to professional staff associated with agencies requiring background checks for the protection of minors, once meetings are verified in terms of strategy and content.

Program fidelity procedures, assessments and transference of leadership to teens will be reviewed during the training. Co-facilitation is recommended at meetings. At least two facilitators must be trained from each site, to insure the continuation of the weekly meetings.

**Teen AA is neither treatment nor therapy. It is an educational program which may be included as part of either process and/or within a non-clinical setting.**
